THE CASINO SOPRON INFORMS THE PLAYERS UNDER RESTRICTIONS BASED ON COURT A DECISION OR A SIGNIFICANT SELF-RESTRAINING STATEMENT, ABOUT THE ROLE OF THE PLAYER PROTECTION REGISTRY

Since January 15, 2016 the Casino Sopron contributes to improve the protection of players, who are restricted on the basis of a court decision or by a voluntary decision from gambling.

The increased protection refers to two groups of persons above 18 years of age: namely who are who are restricted from gambling on the basis of a court decision, or by a voluntary decision. Subject to restrictions based on court decisions are people who must not participate in gambling because of a full or a partial restriction of said person's capacity, due to gambling addiction or dependency. Persons, who are subject to restrictions based on court a decision, may not sign contracts, so their ability to sign contracts in connection with the gambling participation is restricted or limited as well, therefore their protection is justified. Subject to restrictions based on an a voluntary decision are those players, who have given a significant self-restraint statement on their own decision - due to gambling addiction or for whatever reason - and therefore after the verification of their identity, they are excluded from gambling for a period of 1-5 years. Together with the state tax authority we support the decision of those players who have given a significant self-restraint statement. The data for identification of persons under a voluntary decision or under restrictions based on court decisions - in connection to specific games and gambling organizers - is included in the player protection registry. The player protection registry is kept by the National Tax and Financial Authority (NAV). The data in the registry come from two sources: in case of restrictions based on court decisions from the database provided by the court, and in case of restrictions based on own decisions, it is referred to the self-restraint statement.

The registry does not contain any data of the reasons for the restriction - e.g. gambling addiction or any other reasons -, so neither the leading authority, nor the organizer will know the real cause of the restriction. During the phase-in period from January 15, 2016 the casino has granted access to the data of the player protection registry.

Casino Sopron checks the player's data at his first registration, then at each entry, he controls whether the player is restricted according to the player protection registry. If according to the player protection registry the guest is subject to any restrictions, the organizer cannot register the player, or if the player is already registered, he cannot provide the restricted player any playing opportunities.

With regard to recognizing gambling addiction, its treatment, or reducing its harmful impacts, after January 1, 2016 the relevant expertise in health care, social services, family protection and family support services, furthermore nongovernmental civil organizations are dealing with. From December 1, 2015 the

game organizers, such as the Casino Sopron have to publish the contact information of these expert organizations on their websites, furthermore from January 15, 2016 also in form of informative booklets.

QUESTIONS AND ANSWERS

What is the purpose of the player protection registry?

The player protection registry protects those persons, who are under restrictions based on court decisions or who made a significant self-restraint statement. With the help of the player protection registry, the organizer can ensure that persons, whose legal capacity is limited based on court a decision (who may not sign contracts or make legal statements), do not participate in casino gambling, in the card rooms, or on online gambling websites. The purpose of limiting access to players, who signed a significant self-restraint statement, is to support their decision.

Are only those players registered in the player protection registry, who are having gambling addiction?

No. The player protection registry protects those persons, who are under restrictions based on court decisions, or who made a significant self-restraint statement. The legal restriction can be based on other reasons besides gambling addiction; the cause of the legal restriction is not recorded in the player protection registry. The significant self-restraint statement is made by the player without the justification and the indication of the cause, therefore the cause of the restriction and its background is not recorded. The player protection register therefore must not include the data for gambling addiction, the registry may not be considered as a register of gambling addicts.

Is the leading authority of the player protection registry going to deal with the treatment of gambling addiction after 2016 as well?

No. Problem gaming and gambling addiction will be still managed by the appropriate experts in health care, by social services, family support and familyprotection organisations. In order to get a wider dissemination of gambling addiction, from December 1, 2015 the information about the contact details of game addiction services will be also published on the casino's website. The state tax authority shall verify the gambling organizer's player protection and disclosure obligations, while tasks related to the recognition and treatment of addiction will not be carried out in 2016 either.

Which of my personal data may be recorded in the player protection registry?

The player protection registry contains the player's personal identification data, the nature of the restrictions (based on the court or the player's own decision), the restriction in connection with the specific type of gaming, and the gambling operators, as well as the duration of the restriction. The identification data is fully identical with the data base, which the organizer already received at the player's first entry, when the identification process was carried out (first name and surname, names at birth, mother's name, date and place of birth, the type and number of the person's identification document and his address).

Why is the Casino Sopron obliged to use the player protection registry?

It is subject to anti-money laundering regulation and, therefore the casino is also currently recording the data of the players at their first entry and registration. Any legal limitations and restrictions, and any decisions made by the player's own decision will enforce in practice, after the required player's identification, which is from January 1, 2016 during the phase-in period, exclusively in the case of the casino (card room, remote gambling, online casino games) mandatory at games, which requires the person's identification.

How are players under restrictions filtered out by the organizers?

From January 1, 2016 the organizers (the Casino Sopron already from January 15, 2015) check - in addition to the player's registration at his entry - also, whether a player is listed in the player protection registry. To start the query, the casino has to enter the player's data, which is already recorded in its register. The organizer will receive only one data which is not known: namely, whether the player is under restrictions, or not. If a player is subject to restrictions, the player cannot be registered; an already registered player cannot enter the casino.

A short proof of the inquiry, showing the restriction will be handed over to the player by the organizer in the casino in a printed form.
